







Recent Tsunamis

Six Tsunamis in Twelve Years






BC Canada - Oct 2012

- Duration Staffing fatigue / jurisdiction inconsistencies




Deep Ocean Assessment and Reporting of Tsunami (DART) Buoy



National Tsunami Warning Center (NTWC)

Official NOAA Alert Bulletins



Tsunami WARNING (>3 feet)

Widespread inundation is imminent or occurring
Full Evacuation Suggested, Move to Higher Ground
<u>Tsunami ADVISORY</u> (1 foot to 3 feet)
Strong currents are imminent or occurring
Move Away From Shore, Harbors, Marinas

<u>Tsunami WATCH</u>

There is potential tsunami which may later impact your area


Stay Alert For More Info, May be upgraded to Warning/Advisory

California Notification Process



- California State Warning Center Notification to County Warning Points (Usually Sheriff's Dispatch)
- Tsunami Event Distribution List
 - Tsunami Program Contacts: Text, Email, Phone
 - UCSB Jim Caesar
 - Notification Contains: Info Regarding Tsunami Event (What we Know), Basecamp Information, Box.com Conference Call Information
 - Distribute Playbook Recommendation (Maritime & Evacuation)
- Begin Conference Call Process





Local Tsunami Threat

Natural <u>Warning</u> Signs

- Feel Strong Earth Shaking
- See Water Receding Exposing Sea Floor
- Hear Loud Ocean Roar
- <u>Response:</u> One or more Natural Warning Signs –
- Go Immediately to High Ground or Inland
- Stay There



- Prepare: Sign up for Alert Notifications -
- Follow NTWC on Twitter, Activate Notifications on Twitter Account
- Download MyShake App
- Sign up for USGS Earthquake Notifications





Offshore Safety

- Local Source Tsunami Leave Boat
- Distant Source Tsunami: Stay/go offshore 30 fathoms/180 feet
- Stay there until local officials allow return
- Have a Plan
- Be Prepared for at least 2 Days
 - Gas
 - Food
 - Water
 - Other provisions?
- Home Harbor May be Destroyed
- Neighboring Harbors May be Destroyed
- Weather
